MEMORANDUM OF UNDERSTANDING

Between

Qiriazhi University College

And

MODUL University Vienna

Academic and Research Collaboration

Preamble

To continue to promote the advancement of international understanding, academic excellence, dissemination of learning and strengthening cultural ties, Qiriazhi University College and MODUL University Vienna agree to pursue collaboration on academic and research related activities as detailed in this Memorandum of Understanding.

Article 1

The purpose of this Memorandum of Understanding is to facilitate Qiriazhi University College and MODUL University Vienna to achieve their objectives as set out in Article 2.

Article 2

The objectives of the Memorandum of Understanding are to promote and facilitate cooperation and exchange in research and academic work in the areas of mutual interest including:

1. Both institutions are guided by mutual interest to contribute toward the future development of academic and cultural cooperation.
2. The cross-cultural exchanges and programs conducted under this agreement may involve students, professors, visiting scholars, administrative staff, educational materials and cooperative efforts in research projects.
3. Both institutions will accept qualified students upon the recommendation from the home institution.
4. The two institutions shall inform each other about available courses, the financial terms and the accommodation possibilities well in advance of the application deadlines.



5. The two parties agree upon finding ways and means to establish faculty exchange and make a written agreement on this exchange.

Article 3

To implement the objectives expressed in Article 1 and Article 2 the following is mutually understood and agreed:

1. Proposals for collaborative work under this Memorandum of Understanding will be submitted through liaison officers designated by each institution to assure conformity with the aims and purposes expressed in Article 2.
2. The terms and scope and conditions of each project will be described in separate Letters of Agreement which will be prepared subsequent to this Memorandum of Understanding and signed by both parties prior to initiation of each project.
3. All research derived from the collaborative efforts of the two parties will be the joint property of both parties unless otherwise specified in a Letter of Agreement prepared for each project.
4. This Memorandum of Understanding is signed for cooperation between the institutions in the pursuit of the objectives expressed in the preamble. Nothing in this agreement shall be construed as creating a legal relationship between the parties.

Article 4

1. The Memorandum of Understanding is effective as of the date of execution by the appropriate officer of each signatory institution.
2. This Memorandum of Understanding may be amended at any time by mutual consent. It shall be in effect for five years and shall renew for a subsequent five-year period until specifically terminated by either party.
